Concession Rates: Food Vendors will pay a concession rate of 22% of gross sales after sales tax, against a non-refundable guarantee (\$750.00**). Settlements will be made periodically throughout the event and final settlement will be made at checkout. Vendors must understand that these settlements will be made on the honor system and promise to give a fair accounting of sales. *Space is limited and priority consideration for participation in future events will be given to the most successful vendors.*

***\$650.00 if application and guarantee received by February 15, 2011.*

Utility Rates: A \$75.00 utility fee will be charged to all food concessionaires. This fee includes water, electric, trash removal and general grounds clean-up.

Acceptance:

For those applications received by March 1, 2011, review and notification of acceptance or rejection will be completed by April 1, 2011. Vendors accepted to the Freedom Fest State Fair will be required to review and accept the terms of the vendor requirements and submit all forms (Hold Harmless Agreement, Insurance, etc.) and fees by May 1, 2010.

Vendors accepted after April 1, 2011 will be required to review the terms of the vendor Requirements and submit all forms (Hold Harmless Agreement, Insurance, etc.) and fees by the latter of May 1, 2011 or within fifteen days of acceptance, but no later than July 1, 2011.

Acceptance as a Food Concessionaire to the Freedom Fest State Fair may be revoked for any vendor failing to submit paperwork and fees (including the \$750.00 non-refundable guarantee) by the applicable dates requested above.

Proposed Menu:

To better partner with our food concessionaires, the Freedom Fest State Fair has decided to limit the total number of vendors and set limitations on the number of vendors that can sell particular food items. Please assist with this process by listing all items that you intend to offer for sale **in the order of importance to your operation**. The appearance of a food item on this list does not guarantee the right to sell that item during the Freedom Fest State Fair. Each food concessionaire will be informed of their approved menus with the Acceptance Agreement.
